Beginning **May 7, 2025**, State-issued drivers licenses and ID cards that do not meet REAL ID Act standards cannot be accepted for official purposes.

“Official Purposes” include....

- **Entering nuclear power plants**
 - **Unescorted, Escorted (Visitors)**

Other acceptable forms of ID

The Real ID Act requirements only apply to State-issued driver's licenses and identification cards.

When the REAL ID Act goes into effect, **other forms of identification will still be considered acceptable by the NRC.**

Examples of alternative photo IDs still considered acceptable:

- U.S. passport or passport card
- Foreign government-issued passports
- HSPD-12 PIV cards
- Permanent resident cards
- Border crossing cards
- Canadian provincial driver's license or Indian status card
- TWIC card
- U.S. Citizenship and Immigration Services Employment Authorization Card (I-766)
- U.S. Merchant Mariner Credential
- Veteran Health ID Card (VHIC)
- Photo ID issued by a Federally recognized Tribal Nation/Indian Tribe

*You will need a Real ID to enter nuclear sites this fall. Please get this taken care in advance as Real IDs can take up to 3 weeks to arrive. Make sure to provide our office with a copy for our records. If you **do not** have a Real ID, a passport or one of the ID alternatives listed above are acceptable with your Drivers License. VEHICLE SAFETY

All personnel operating a company vehicle are obligated to conduct a thorough inspection prior to any vehicle being brought on site at any facility including physically viewing the condition of the vehicle and the safety of the anticipated vehicle path.

All vehicle occupants shall wear seatbelts, at all times when the vehicle motor is running and when the vehicle is moving.

Trucks, vehicles and equipment exceeding 11,000 LB shall use wheel chocks when parked.

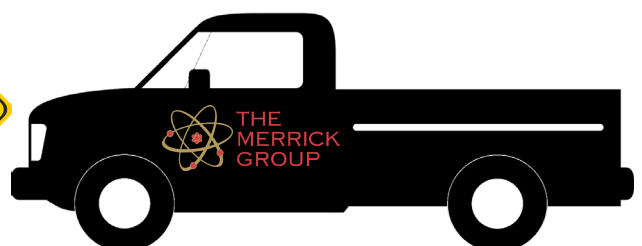
All vehicles shall be shut off during refueling.

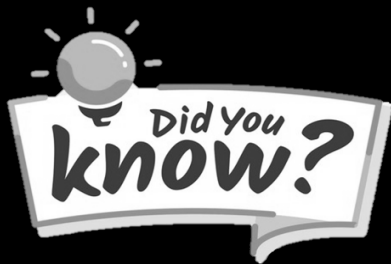
The use of cell phones or computers is prohibited unless the vehicle is in park.

All vehicles' registration and inspection shall be up to date, at all times. Current insurance card shall be kept in the vehicle at all times.

Keys shall be removed from the vehicle prior to it being left on site. The vehicle shall be locked at all times when left on site. All trailers shall be locked at all times while in motion and while left on site.

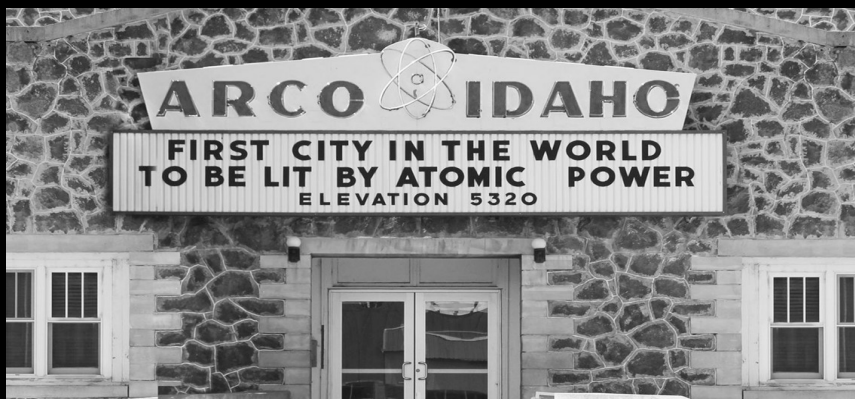
All vehicles shall be cleaned out upon return to the shop leaving no trash, PPE, or tools behind.





Arco, Idaho was the world's first town powered by atomic energy.

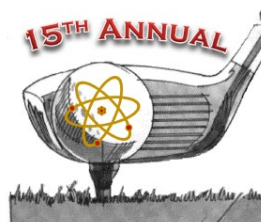
